Instructions for Recipient

Recipient's taxpayer identification number (TIN). For your protection, this form may show only the last four digits of your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN). Account number. May show an account or other unique number the payer assigned to distinguish your account.

Otherwise, file by February 28, 2020, if you file on paper, or by March 31, 2020, if you file electronically.
